

## **Information about the risks involved in your participating in Hyundai Driving Experience events and Liability Waiver**

The participant enters and uses the race track/the training area on which the events are held at his/her own risk and peril.

### **Information about driving training risks:**

In the case of the driving training offers, you will receive a theoretical briefing and driving instruction from our professional instructors. Irrespective of this, you drive the race track/the training area yourself in the presence of the instructor and are therefore responsible for the operation and control of the vehicle. Depending on the event booked, driving manoeuvres are practised that go beyond the normal use of the vehicle in road traffic and are therefore associated with an increased risk.

### **Information about race taxi risks:**

Within the scope of the event "Hyundai TCR Race Taxi" und "Hyundai N Taxi" (hereinafter together referred to as: Race Taxi), the participant takes part as a co-driver. The participant drives as a co-driver in a Hyundai racing car with 350 hp or a street-legal Hyundai N model on the respective race track/the respective training area. The drivers used for this purpose have extensive experience on the respective race track/the respective training area, resulting either from their own motorsport experience or from professional involvement (including as an instructor at driving training courses or as a test driver/test engineer).

During the Race Taxi drive, high speeds are reached on the race track/the training area. In particular, high cornering speeds, as a result of which an extreme centrifugal force occurs and strong physical forces act on the vehicle and the passengers. There will be other professional and non-professional drivers and vehicles using the race track during the event, creating the risk of collision and accidents in general beyond the control of the Race Track driver. Furthermore, external circumstances (such as weather-related circumstances) that are outside the driver's sphere of influence can have an impact on the driving event.

**Typical risks associated with participation in Hyundai Driving Experience events include (exemplary, non-exhaustive list):**

- **Collision with other professional and non-professional vehicles on the track;**
- **Loss of control of the vehicle due to traces of oil and operating fluids on the race track/the training area, ice, snow;**
- **Accident hazards and accident occurrence due to the misbehaviour of other drivers (e.g. heavy braking, incorrect steering behaviour);**
- **Accident risks and accident occurrence due to technical defects;**
- **The effect of high centrifugal forces on the body;**
- **nausea;**
- **high speed;**
- **altitude sickness.**

**The participant is aware of the fact that the possibility of traffic accidents due to technical and/or human failure exists in principle and cannot be excluded.**

## Liability Waiver:

The participants (as driver, co-driver, accompanying person, guest, or otherwise staying at the facility or participating in transfer trips, hereinafter referred to as participant) enters and uses the respective facilities at his own risk. He/she shall bear sole responsibility under civil and criminal law for all damage caused by him/her or the vehicle used by him/her. He/she declares the waiver of claims of any kind and on any legal grounds for damages arising in connection with the use of and/or stay at the facility against

- the vicarious agents and assistants of all the aforementioned, hereinafter

referred to as beneficiaries.

This waiver does not apply to damages resulting from injury to life, body or health due to a culpable breach of duty by the beneficiary and does not apply to other damages due to an intentional or grossly negligent breach of duty by the beneficiary, or in the case of an express warranty of characteristics.

For a minor participant, his/her legal representatives must provide the required declarations.
